
Joys and Concerns



Eye on the Board

The Board of Trustees met on Sunday, November 27, and had a large agenda. The regular reports were reviewed. Donations of \$25 will be made to the Ministry of Concern and the Downtown Association. \$2,013 will be moved from the Restoration Fund to the checking account. We have \$5,300 in cash in the Scottrade account. The endowment is holding up well and was at \$443,060 at the end of October. The market has gone down and then went back up and has been climbing.

Payne's Carpet completed the work on the rug, and it looks great! Dennis Seekins had Turnbull come in to do an estimate on the chimney, and they recommended that a fireplace enclosure be added because the current set-up is generating moisture in the chimney, causing deterioration. Turnbull is not able to do that aspect of the work and recommended Big Ash. All-ways Warm was also mentioned to get a possible estimate.

The hot water heater is venting only partially and so heat is not going up the chimney. It is melting parts of the heater. Replacing the gas water heater with an electric one is one option, which would solve a lot of the problems. Jim explained that in order to do that, we would need a 220v plug/line added. He will also obtain an estimate for updated electrical outlets (grounded outlets) throughout the church. In addition, Jim said he may have someone to do work on the ceiling.

A workbee has been scheduled for Saturday, December 10 from 9-noon, and more work will be done on the office area. Someone will be needed to remove snow and ice from the sidewalks this winter, and Richard Nenni will be called to see if he is interested.

The Jedi Knight group has not been happening, and ways will be explored to advertise more. The book discussion group in November was a robust talk, and the Board is considering having one every other month with book input from the congregation. Another group will meet in February to talk about the book, 'Rise of the Military Cop'. Rich is working on a service to be held in the Spring, which will be a combination of poetry readings, music, and other offerings concerning women's issues. Rev. Lori Staubitz will be in the pulpit for the Annual Candlelight Service and musicians have been lined up. Christmas bonuses were discussed. Rich Della Costa attended a Regional Workshop about partnerships between congregations. Joan VanBecleare led the discussion, and Rich reported on how that went and made some recommendations. Darrell will be attending a conference in Amherst on 'Right Relations' in January.

The Cobblestone Society has requested to meet at the church and the Board approved this. The wine tasting event was discussed and while it is too late to work on it for the Spring, we may have the event in the Fall. New member outreach was also discussed. The next Board meeting will be held on Sunday, December 18th.

Book Discussion Report

On November 6th, a small group met to discuss the book 'A Mother's Reckoning - Living in the Aftermath of Tragedy' by Sue Klebold. Seventeen years ago, Sue's son Dylan along with Eric Harris, walked into Columbine High School in Littleton, Colorado at 11:15 AM with assault weapons and bombs and shot and killed 12 students and one teacher, wounded many others, and then killed themselves. The media's response was wall to wall coverage of the event for weeks, showing screaming children running out of the school. Eric Harris and Dylan Klebold were mentioned over and over, their lives were examined, there were aerial views of their homes, and it was surmised that they were bullied, outcasts, Satanists, indulged brats, etc.

The group examined what Dylan's parent went through when the event first took place. They were removed from their home for many hours, not told anything, and then allowed to get a few things and leave. Eventually, they learned their son was dead. The media blamed them right away, saying they must have ignored their son, allowing him to make bombs in the basement, bought him expensive cars and guns and so on. In reality, according to Sue Klebold, they were the kind of parents who read to their children, didn't allow guns in the house, spent a great deal of time with their children. In other words, they were a typical family, or so they thought. Mrs. Klebold was not asking for forgiveness for her or her son, but wanted to caution parents to be more aware of their children if something seems a bit off. The Klebolds became a pariah in their town, and even getting a haircut was difficult. Since this event, they have lived in a virtual hell.

The truth is that the boys were not outcasts in the school, and the bullying was pervasive throughout the school. They weren't overindulged, they weren't Satanists, they weren't goths, they weren't gay. But Eric Harris was likely a Psychopath who wanted to kill, and Dylan was depressed and wanted to die. The two boys meeting and becoming friends was like a perfect storm of horror. And they both were very good at deception. They didn't let their parents know who they really were.


The group examined a few questions such as 1.What could the Klebolds have done to prevent this tragedy? 2. How aware were we about what the boys' families have gone through? 3. How could Sue have been so wrong about her son? 4. Is Sue's warning legitimate? 5. What is intrusive into your child's privacy and what is necessary? 6. How did the media contribute to the family's suffering? 7. What should you do if you feel your child is hanging around a bad influence?

It was a great discussion. If anyone has an idea for another book we might check out, please see Chris Loss!!

Harlequin Christmas Fudge (provided by Chris Loss)

3 oz. package softened cream cheese
3 cups confectionery sugar
Dash salt
1/2 cup chopped mixed candied fruit and chopped walnuts
